Members in this category will receive member-to-member event discounts, such as reduced fees for chamber breakfasts, luncheons, annual meeting, and other special events. You may also serve on committees and receive weekly chamber communications.

Your name, however, will not be listed on the chamber's website, in its online directories, or printed in its annual publications. In addition, you will not be eligible for programs specifically designed for business members, such as co-op advertising, health insurance, or other programs/events specifically intended for businesses promotion or advocacy.

MULTIPLE SMALL BUSINESS MEMBER DISCOUNT

If you are a small business owner with multiple businesses in the Southern Midcoast Region, we are pleased to offer you a discount for multiple business memberships. Simply pay full price for the business with the most employees, and your other businesses located in the Southern Midcoast Region can be listed on the Chamber's website and publications for a simple \$55 fee. To receive this discount, you must have 10 or less total employees working at your primary business and affiliates.

Example: Primary Business is Flower Shop with owner and 5 employees, secondary business is owner selling in-home care products, and tertiary business is owner plus 1 employee cutting hair. The primary business is also a member of a recognized downtown association within the SMMC's 16 town region. Discounted dues would be:
